- 2. Four current-colored photographs, including both sides, a direct face and a rear view, clearly showing all face and leg markings, as well as close-up photographs of any brands and/or scars. Photographs must be on photo quality paper and not larger than 4x6 inches (10.2 cm x 15.2 cm). The ApHC reserves the right, at its discretion, to require additional photographs of better quality. Pictures become the property of the Appaloosa Horse Club. (If your Appaloosa's description has changed, the ApHC will describe your horse as it appears in the new photographs submitted)
- 3. Correction fee \$50 (fee subject to change).

4. If you are the current owner (not recorded with the ApHC), there must be a **Transfer Report Form** completed by the last recorded owner (selling this horse) submitted with this form.

Should your request for a new certificate, or photographs submitted, contain any discrepancy that would bring into question the identity of the Appaloosa, the Registrar may require additional photographs or inspection of the animal. If for any reason, the ApHC cannot complete the new certificate, the ApHC shall retain the original Certificate of Registration and an office charge shall be assessed. Allow 6-8 weeks for normal processing.
